SECTION 2. HAZARD(S) IDENTIFICATION:

Hazard Description: Harmful; pharmaceutically active substance

Harmful if swallowed

May be harmful if inhaled or absorbed through the skin

Ingestion may result in elevated liver enzymes (ALT/AST)/hepatotoxicity, hyperbilirubinemia (increased levels of bilirubin in the blood), palmar-plantar erythrodysesthesia syndrome (also known as hand-foot syndrome manifested as redness, tenderness, peeling, blistering, and ulceration of the palms and soles), rash, alopecia (hair loss), asthenia (lack of muscle strength), fatigue, anorexia (decreased appetite), weight loss, diarrhea, mucositis (inflammation and ulceration of the mucous membranes lining the digestive tract), infection, hypertension (elevated blood pressure), dysphonia (impairment of the ability to produce voice sounds using the vocal organs), anemia, lymphopenia/neutropenia (reduced levels of different types of white blood cells), thrombocytopenia (reduced blood platelets), increased INR (slower coagulation), hemorrhage, elevated levels of serum lipase/amylase, hypothyroidism, dysgeusia (distortion of the sense of taste), xerostomia (dry mouth), gastroesophageal reflux, gastrointestinal perforation, hypocalcemia (low serum calcium levels), hypophosphatemia (reduced serum phosphate level), hyponatremia (reduced serum sodium level), hypokalemia (reduced serum potassium level), musculoskeletal stiffness, pain, headache, tremor, proteinuria (excess serum proteins in the urine)

SECTION 4. FIRST-AID MEASURES:

After Inhalation: If inhaled, remove to fresh air; if breathing is difficult, give oxygen; if breathing stops, give artificial respiration

After eye contact: check for and remove contact lenses; flush with copious amounts of water; assure adequate flushing by separating the eyelids with fingers; call a physician

After swallowing: if swallowed, wash out mouth with copious amounts of water; call a physician

Suitable extinguishing agents: water spray, carbon dioxide, dry chemical powder or foam
