### SECTION 2. HAZARD(S) IDENTIFICATION:

Hazard Description: Toxic

RTECS Substance category: Drug; Mutagen; Human Data; Reproductive Effector  
Harmful if swallowed

May be harmful if inhaled or absorbed through the skin

Exposure may impair fertility, may cause harm to the unborn child, and may cause cancer

Ingestion may cause leukopenia and neutropenia (decreased white blood cells), anemia, thrombocytopenia (decreased blood platelets), amenorrhea (suppression of menstruation), hot flashes, lethargy, pyrexia (fever), nausea/vomiting, mucositis (inflammation of the mucous membranes lining the digestive tract, especially mouth sores), diarrhea, anorexia (loss of appetite), infection, febrile neutropenia (development of fever/other signs of infection in association with abnormally low number of a certain type of white blood cells), conjunctivitis/keratitis (inflammation of the eyes), alopecia (hair loss), local toxicity, rash/pruritus (itch), skin changes

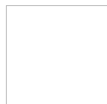

#### **SECTION 4. FIRST-AID MEASURES:**

After swallowing: if swallowed, wash out mouth with copious amounts of water; call a physician

Person-related safety precautions: cordon off area of spill; wear self-contained breathing apparatus, protective clothing and heavy rubber gloves

Measures for cleaning/collecting: absorb solutions with finely-powdered liquid-binding material (diatomite, universal binders); decontaminate surfaces and equipment by scrubbing with alcohol; dispose of contaminated material according to Section 13
